New Slogan for Meadowbrook Estates Civic Association

The Board of Meadowbrook Estates Civic Association (MECA) is adopting a "slogan", "theme" or "brand" for Meadowbrook Estates.

The slogan comes from input from neighbors as well as our interaction with county officials, who see many, if not all, of the neighborhoods in Chesterfield County.

County officials tell us on many occasions and in many different ways that Meadowbrook Estates neighborhood is unique. By comparison we have a low crime rate. They have even said that we look like an oasis in the crime statistics. That is because we have banded together to report suspicious activities. The police respond because we have a good relationship with them. We have a certified neighborhood watch patrol that is staffed by any neighbor who can spare an hour or two each week. Our efforts are not 100% effective, but if we continue, they will be.

County officials also tell us that we continue to have a well-maintained neighborhood. We do this through litter patrols staffed by any neighbors who can spare the time to patrol their property, street or larger eyesore areas like the fence on Hopkins Road. We like to see that our properties are in reasonable compliance with county codes. We try not to nitpick, but focus on issues that neighbors bring to our attention. We will organize volunteer teams to provide help to neighbors who need it. We have cut fallen trees out of roadways when the county was overwhelmed by storm damage. We have cleaned up streets that V-DOT has ignored. We have a board member who reports street light outages and follows up until repairs are made. We maintain the median on Edgemere.

For all these and other reasons, the County officials use Meadowbrook Estates as an example of what neighbors working together can accomplish.

MECA did a neighborhood survey in 2017 (results published in Meadowlark) and again in 2020 (results coming soon). Both surveys showed that the neighbors placed emphasis on safety and appearance. So, what the county recognizes and what the neighbors value are essentially the same.

Both are essential elements of the slogan, theme, or brand that is being adopted: "Neighbors helping to create a Clean, Safe, and Enjoyable Neighborhood". So, the next time someone asks where you live, please respond, "Meadowbrook Estates where neighbors help create a clean, safe, and enjoyable neighborhood."

To help all of us remember this phrase we will use it in Meadowlark, the web site, at meetings, etc. If we say this a lot, and believe it, over time we may create a "slogan". By working together, we will make this slogan endure for a long time.
